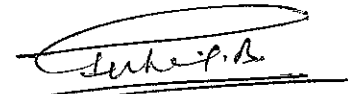

I, S Kannan, Practicing Company Secretary, appointed as Scrutinizer for the purpose of the poll taken on the resolutions indicated in the Notice sent to the shareholders of the Company through e-voting and postal ballot and by poll at the Annual General Meeting (AGM) of the company held on 6<sup>th</sup> May, 2015 at “Grand Ball Room”, Second Floor, Sheraton Bangalore Hotel, Brigade Gateway, 26/1 Dr. Rajkumar Road, Malleshwaram- Rajajinagar, Bengaluru – 560055 at 11.00 A.M, submit my report as under:

1. The e-voting commenced at 9.00 AM on 2<sup>nd</sup> May 2015 and concluded at 5.00 PM on 5<sup>th</sup> May 2015. The Company had sent the annual reports to 26886 shareholders through e-mail. Out of 26886, 111 shareholders had cast their votes thro e-voting system.
2. Physical copy of the Annual Report was sent by Speed Post to 37496 shareholders to whom opportunity to participate in the poll through postal ballot was provided. Out of 37496 shareholders, 223 shareholders had cast their votes.
3. Amongst the shareholders who were physically present at the AGM, 96 Shareholders had cast their votes by ballot.
4. After the announcement on polling at the AGM, 4 ballot boxes were duly locked by me and kept for polling with due identification marks.
5. The locked ballot boxes were subsequently opened by me. As per Law, I counted the votes cast at the meeting and then unblocked the votes cast through e-voting in the presence of two witnesses who are not in the employment of the Company and are well versed with the e-voting system.
6. The poll papers were diligently scrutinized and were reconciled with the records maintained by the Company/ Registrar and Transfer Agents of the Company and the authorizations / proxies lodged with the Company.
7. The Poll papers, which were incomplete and/ or which were otherwise found defective have been treated as invalid and kept separately.

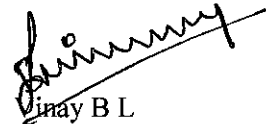


