

TERMS AND CONDITIONS OF PARTICIPATION

Motor Challenge

I General

These Terms and Conditions of Participation govern participation in the "ABB Motor Challenge: ABB is on the hunt for Switzerland's oldest motor", conducted by ABB Switzerland AG Requests to participate in the ABB Motor Challenge can be submitted electronically from **September 2, 2024, to October 11, 2024**. There will be an announcement by ABB Switzerland AG to existing and potential customers based in Switzerland, asking the following question: "Do you have the oldest motor in Switzerland?" The customer who can present the oldest motor (which does not have to be an ABB motor) will win a replacement motor from ABB along with an additional frequency converter with a total value of up to CHF 50,000.

II Eligibility for participation

- 1. Companies organized under private law with a registered office in Switzerland are eligible to participate.
- 2. State-owned or semi-state-owned companies are excluded from participating in the ABB Motor Challenge.
- Only companies that are authorized by law and their internal guidelines to accept a motor and a frequency converter with a total value of up to CHF 50,000 are eligible to participate.
- 4. No company location may participate in the ABB Motor Challenge more than once.
- ABB companies, as well as agencies or partner companies commissioned with executing the ABB Motor Challenge, are excluded from participating in the ABB Motor Challenge.
- 6. Participation with temporary or fictitious email addresses, using scripts, registration services or similar methods is prohibited.

III Participation

- To participate in the ABB Motor Challenge, participants must correctly and truthfully complete an online form provided by ABB Switzerland AG and confirm their participation by October 11, 2024.
- The motor the participant enters into the ABB Motor Challenge must still be operational and have a minimum operating time of 2000 hours per year.
- Only participation in the ABB Motor Challenge entitles the participant to enter into the prize drawing.

IV Mechanism

- Participation in the ABB Motor Challenge is only possible online. Participants must accurately and truthfully complete a <u>form</u> provided by ABB Switzerland AG online by October 11, 2024. In addition, participants must specify the type of motor and the year it was manufactured and add a photo of the nameplate.
- 2. To enter into the prize draw, participants must provide their company name, position, first and last name of the contact, postal address and email address at the end. They must also accept the Terms and Conditions of Participation and acknowledge the Privacy Notice. ABB will respond by sending an email confirming participation.

V Motor Challenge Prize

Participants have the chance to win a replacement motor from ABB as well as an additional frequency converter, both of which provide the same performance as the motor to be replaced, with a total value of up to CHF 50,000. The following limit applies to replacement devices:

- Performance range: 5.5 200 kW
- Number of pole pairs: 2, 4, 6
- IEC Low voltage motors

ABB Switzerland AG (Motion Market Organization) will deliver the motor and the frequency converter to the winner and commission the device. Installation is not included. ABB Switzerland AG assumes no system responsibility for modifications. This means that if approval is required, it must be requested and obtained by the customer, not by ABB Switzerland AG. ABB Switzerland AG cannot guarantee that the approval will be granted. ABB Switzerland AG's General Conditions for the Supply of Products and Components (2024) apply to the services provided by ABB Switzerland in connection with the motor and the frequency converter. ABB Switzerland AG will promptly deliver the prize after the winner is announced. The winner must complete the conversion to the new devices within three (3) months of receiving the devices.

VI Prize award

1. General information and responsibility

ABB Switzerland AG is responsible for conducting the ABB Motor Challenge. All decisions regarding the Motor Challenge will be made in consultation with the responsible ABB employees, who also have the final decision-making authority. The confirmed decisions, as well as the results of the Motor Challenge, are final.

2. Prize award

The participant who can present the oldest motor will receive the prize. If multiple participants present a motor produced in the same year, the participant with the oldest date on an invoice, drawing or other technical document will be declared the winner. If data from multiple participants matches, the motor that was submitted first will be selected.

3. The winner is required to participate in a success story. This means that ABB Switzerland AG will write an article mentioning that the participant has won a motor. The article will also feature a video documenting the winner's motor. The article will appear in ABB Switzerland AG's electronic customer magazine and will be shared on social media (YouTube, LinkedIn and Instagram).

VII Transfer of the prize

- 1. The winner of the prize will be notified by email within five (5) business days after the evaluation.
- The prize will be delivered to the address specified by the winner. Delivery to locations where cars are not permitted, such as Zermatt or Saas Fee, or to places inaccessible to trucks will be invoiced to the winner based on the expenditure involved.
- 3. No cash payout of the prizes will be made. ABB may replace any awarded prize at any time with another equivalent prize.

VIII Miscellaneous

- Participants who violate the conditions of participation, manipulate and/or breach regulations to prevent bribery and corruption may be excluded from the ABB Motor Challenge. If the conditions for exclusion are met, appropriate corrections may be made to the rankings, winnings may be revoked (even retroactively) or winnings that have already been delivered may be reclaimed.
- ABB as the organizer, or the agencies or partners commissioned with executing the ABB Motor Challenge, are entitled to terminate, cancel or suspend the ABB Motor

- Challenge if proper execution can no longer be ensured. This applies especially in the event of hardware or software failures, program errors, computer viruses or unauthorized interference by third parties, as well as in cases of mechanical, technical or legal issues.
- ABB is committed to making the ABB Motor Challenge playable on all common web browsers, i.e., the current versions of these browsers. Unsupported web browsers or web browser versions are not grounds for claims to participate in the contest.
- 4. If emails cannot be delivered to the winners (e.g., due to technical issues or spam filters), there is no entitlement to compensation.
- 5. By participating in the ABB Motor Challenge, the participant accepts these Terms and Conditions of Participation as well as the publicity associated with any potential win. In particular, the participant acknowledges that their company name and location may be published both on the ABB homepage (https://new.abb.com/ch or https://global.abb/topic/rhbworldrecord/de) and mentioned or published in other media.
- In the event of an erroneous or incorrect publication, only the prize draw results are decisive for determining the eligibility to win, not any potentially incorrectly published information.
- The data will be shared with third parties if this is necessary in connection with the installation of the motor and the frequency converter.
- 8. ABB Switzerland AG, Bruggerstrasse 66, 5400 Baden, Switzerland, is the company responsible for the personal data provided by the participant and controls its use. ABB Switzerland AG or third parties commissioned by it will process this data to enable participation in and the execution of the ABB Motor Challenge. - 9. There will be no correspondence regarding the result of the Motor Challenge.
