II. Description of item requirements: Phase resolved partial discharge measurement and analysis system – part of dielectric phenomena and power electronics test set .

1. Specification:

Phase resolved partial discharge measurement and analysis system consisting of:

- Mobile partial discharge (PD) acquisition unit with adjustable frequency band including synchronization unit (0.1-1000 Hz) and measuring impedances (at least 5 MHz bandwidth) with built-in overvoltage protection. Selective disturbance gating feature should be included.
- System should allow extension to 3 phase measurements.
- Advanced PD analysis and reporting software packages.
- Calibrator covering charge range 0.1-1000 pC.
- Dry coupling capacitors covering voltage range 20 kV and 100 kV.
- Clamp on high frequency current transformers with frequency bandwidth at least 4 MHz.
- Mixer for ultra high frequency PD measurements with upper frequency up to 2 GHz.
- Operating temperature 0...50 °C.
- Power supply 230 V 50Hz.
- Possibility to supply from mobile battery source.
- Protection case for the system for transportation purposes.

2. The Buyer does not accept partial bids.

3. The bid shall include:

- Net unit price for,
- The cost of transport and installation (net),

In cases where only one or two bids will be submitted, the Buyer reserves the right to invite them for negotiations.

All of the criterias remain the same during the whole process.

10. The bids will be evaluated and weighted as follows:

- Price – 80%
- Payment terms – 20%
