Summer of Sport

Prize Draw Terms and Conditions

1. THE PROMOTER

The promoter of this prize draw is ABB Limited of Daresbury Park, Daresbury, Warrington, WA4 4BT (the "Promoter").

2. THE COMPETITION

- 2.1 The title of the competition is Summer of Sport.
- 2.2 The customers of participating Promoter wholesalers may enter into a series of prize draws by completing and returning a coupon to the relevant wholesaler or to the Promoter.

3. How to enter

- 3.1 The competition will run from 00:00 on the 10th of June 2016 (the "Opening Date") to 23:59 on the 26th of August 2016 (the "Closing Date") inclusive. All competition entries must be received by the Promoter by no later than 23:59 on the Closing Date. All competition entries received after the Closing Date are automatically disqualified.
- 3.2 To enter the competition, complete a promotional coupon, which can be found at the offices of any participating wholesaler, and deposit the coupon in the competition counter post box at those offices by the Closing Date.
- 3.3 Notwithstanding the above, to be eligible to win prizes with a fixed draw date as indicated in condition 5.1, coupons must be deposited in a counter post box ten (10) working days prior to the relevant draw.
- 3.4 A full list of participating wholesalers is available on the Promoter's website.
- 3.5 Please note that only original coupons received by the Closing Date will be accepted. Copies will be rejected.
- 3.6 No purchase is necessary to enter the prize draws.
- 3.7 The Promoter will **not** accept: responsibility for competition entries that are lost, mislaid, damaged or delayed in transit, regardless of cause, including, for

example, as a result of any postal failure, equipment failure, technical malfunction, systems, satellite, network, server, computer hardware or software failure of any kind; or proof of posting or transmission as proof of receipt of entry to the competition.

- 3.8 Wholesalers will send completed coupons to the Promoter's Nottingham office, where winners will be chosen by random draws performed by an employee or employees of the Promoter and supervised by an independent individual. Draws will be held regularly throughout the duration of the competition, with some prizes to be drawn on fixed dates. Please see condition 5.1 for further details of when draws will be held.
- 3.9 By submitting a competition entry, you are agreeing to be bound by these terms and conditions.

4. ELIGIBILITY

- 4.1 The competition is only open to the employees, contractors and owners of customers of participating wholesalers based in the United Kingdom. A full list of participating wholesalers can be found on the Promoter's website. For the avoidance of doubt, and notwithstanding anything to the contrary in these conditions, the following individuals will not be eligible to enter the competition:
 - (a) Employees or contractors of the Promoter or any of its group companies, or any family members of such employees or contractors;
 - (b) Employees, contractors and owners of any participating wholesaler or affiliated company of a participating wholesaler;
 - (c) Family members of any individual described in conditions 4.1(a) to (c) inclusive; and
 - (d) Any other individual involved in the running of the competition.
- 4.2 In entering the competition, you confirm that you are eligible to do so and eligible to claim any prize you may win. The Promoter may require you to provide proof that you are eligible to enter the competition.
- 4.3 The Promoter will not accept competition entries that are: automatically generated by computer; completed by third parties or in bulk; illegible, have been altered, reconstructed, forged or tampered with; photocopies and not originals; or incomplete.

- 4.4 There is a limit of one entry to the competition per eligible individual. Entries on behalf of another person will not be accepted and joint submissions are not allowed. Entrants may not enter via more than one wholesaler. No individual entrant may win more than one prize.

- 6.1 The Promoter will contact the winner personally as soon as practicable after the end of the relevant prize draw, using the telephone number or email address provided on the coupon.
- 6.2 The outcome of each prize draw as is final and no correspondence or discussion will be entered into.
- 6.3 A list of winners can be viewed on the Promoter's website (www.abb.com/campaigns/summer-of-sport) for a period of thirty (30) days.

7. **CLAIMING THE PRIZE**

- 7.1 If you are the winner of the prize, you will have thirty (30) of days from the date on which you are notified to claim the prize by contacting the participating wholesaler at whose site you submitted your coupon to arrange delivery. If you do not claim the prize by this date, your claim will become invalid.
- 7.2 The Promoter will make all reasonable efforts to contact the winner. If the winner cannot be contacted or is not available, or has not claimed their prize within thirty (30) of days of the Announcement Date, the Promoter reserves the right to withdraw the prize.
- 7.3 The Promoter does not accept any responsibility if you are not able to take up the prize.

8. LIMITATION OF LIABILITY

Insofar as is permitted by law, the Promoter, its agents, wholesalers or distributors will not in any circumstances be responsible or liable to compensate the winner or accept any liability for any loss, damage, personal injury or death occurring as a result of taking up the prize except where it is caused by the negligence of the Promoter, its affiliated companies, agents or distributors or that of their employees. Your statutory rights are not affected.

9. DATA PROTECTION AND PUBLICITY

9.1 If you are the winner of the competition, you agree that your name and the name of your business will be displayed on the Promoter's website as stipulated in condition 6.3.

- 10.3 These terms and conditions shall be governed by English law, and the parties submit to the non-exclusive jurisdiction of the courts of England and Wales.
